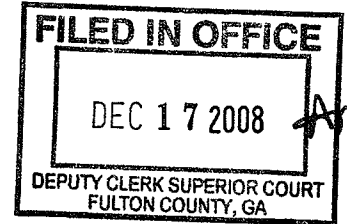


**ORDER DENYING DEFENDANTS' MOTION TO DISMISS
