GSU MOOT COURT TEAM WINS NATIONAL CHAMPIONSHIP

For the first time in the 38 year history of the Association of the Bar of the City of New York's Annual National Moot Court Competition, a Georgia law school became the national champion. Georgia State University team of Linda G. Birchall, L. Craig Dowdy and Rebecca Jones is this year's national

championship team. In the late summer of 1987, one hundred and fifty law school moot court teams from throughout the nation began preparing their briefs and arguments for the regional round competitions held last

November.
The GSU team competed with three other Georgia schools, five Florida schools, and the University of South Carolina in the southeastern regional competition held in Atlanta under the auspices of the Younger Lawyers Section of the State Bar of Georgia.

Georgia State University defeated law school teams from the University of Oregon, Suffolk University, Georgetown University and Fordham University and Fordham University before meeting South Texas College of Law in the final round on

Thursday evening.
In defeating South
Texas College of Law in the final round, Georgia State became this year's national champion. In addition to winning the championship, GSU team member Rebecca Jones was declared best oralist; Rebecca Jones oralist; Rebecca Jones and L. Craig Dowdy were named best oralist team; and Georgia State University received a plaque honoring its second place brief.

According to faculty advisors Norman A. Crandell and Steven Kaminshine, "Ours was truly a team effort. Linda had major responsibility for t brief and Craig and Rebecca argued most of the rounds in the final competition. These competition. three have worked closely together for more than six months and their dedication showed in winning the nation's most presitgious national moot court competi-

- Steven Kaminshine

Professor Kaminshine teaches and researches in the areas of labor law, labor arbitration, collective bargaining, appellate advocacy and employment discrimination law. He came to Georgia State after service with the National Labor Relations Board and four years of private prac-tice. His J.D. degree is from DePaul University School of Law. Professor Kaminshine has completed a major publication, "Workers' Compensation in Georgia," for the Methods of Practice treatise by West Publishing.

As co-faculty advisor of the GSU Moot Court team since 1985, Professor Kaminshine states, "Of all the accolades bestowed on

significant to me was that our brief was touted as the second best brief in the country. In the real world, the brief is crucial in winning appellate arguments."
