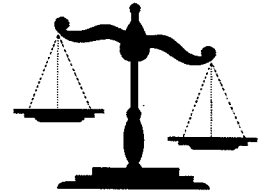

Voice your opinion about GSU's proposed Student Fee Increases

On Thursday, April 14th, the GSU administration will hold a "public hearing" concerning proposed increases in the Student Activity Fee and the Student Athletic Fee.

Currently, the University's fee structure is much lower than similarly situated universities, and the committee which allocates the fees consistently runs short on funds (requests are double the available funds). Because of this, the university would like to increase the fees in the following manner (per quarter/semester):

- *Student Activity Fee --
 raise from \$23 to \$30
- *Student Athletic Fee --
 raise from \$23 to \$33 or \$38
- *Student Health Fee --
 create at a fee of \$5

At the hearing on the 14th, the Administration will take comments regarding these increases/new fees. The hearings will be held in the Student Lounge, third floor, University Center (next to the "big" cafeteria). They will begin at 10:00 am and again at 5:30 pm and run for approximately one hour.

If you are unable to attend (and they have been informed that these times are inconvenient for law students), please submit your comments in writing to the SBA office no later than 10 am that morning, and they will be submitted to President Patton directly. Please keep your comments short, specific and civil -- pro or con (and thanks for your input).

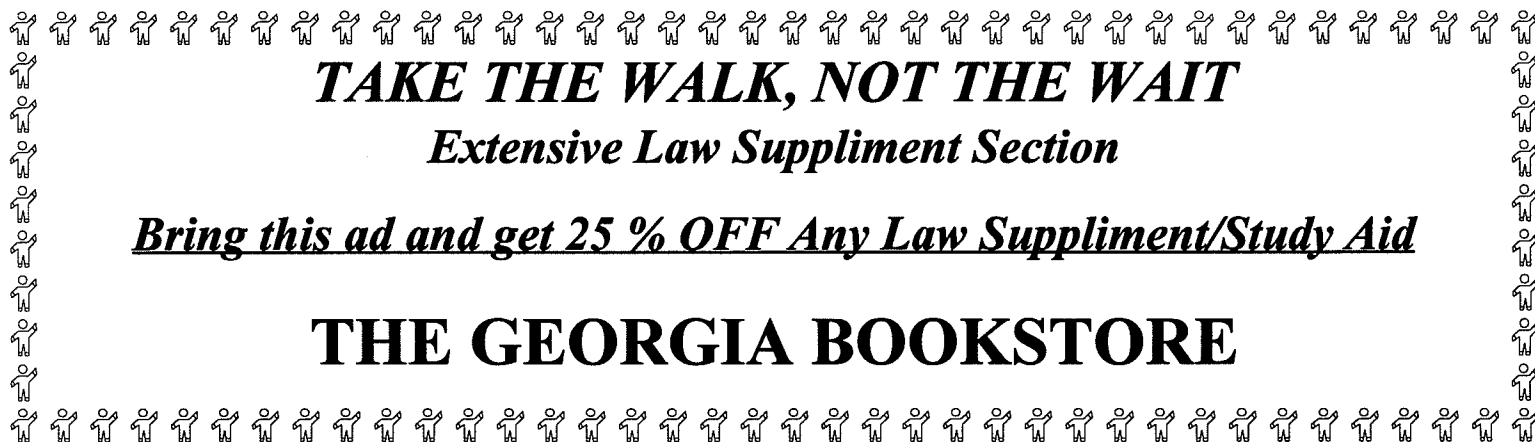

Focus Feature to find/search for particular text

.FO initiates the Focus Feature.

Use the Focus Feature to highlight words in LEXSEE retrieved documents. Use the Focus Feature to change the highlighted words in regular search mode retrieved documents.

How does this work? Simple

.FO <enter>

WORD OR OTHER OR THIRD OR
FINAL <enter>

LEXIS will then highlight those words between the or connectors in either full (.FU) or kwik (.KW) format.

The focus feature is particularly useful when retrieving LEXSEE documents because with focus there are no highlighted words.

The focus feature is also available when your document is retrieved through a standard LEXIS word search. If you want to change the focus of your search just initiate the Focus Feature and enter new words to highlight.

For example, if you search the Georgia library case file for FIRST AMEND! AND ZONING AND GEORGIA AND DATE AFT 1992 you may begin to read *Pel Asso v. Joseph*, 262 Ga. 904 (1993). The highlighted terms will be your search terms: First Amendment, Zoning, Georgia and the date.

To highlight different terms you might enter:

.FO;NUDE OR LICENS! OR
DANCE;.KW <enter>

Now the highlighted terms will change to reflect your narrowed interest.

To exit the FOCUS service enter .EF or .EX -- do not enter .ES -- especially if your case came up as a result of a Lexsee search -- .ES is the dot command to EXIT SERVICE.

Related command:

.VK # (vary the key word context) changes the amount of text surrounding the highlighted words in KWIC (key word in context). The default is 25 words. If you would like to see more or less text than previously, enter a larger or smaller number after the dot command. For example:

.VK 5

LEXIS will change the amount of text surrounding your key focus or search words to five words before and five words after. LEXIS does not count noise words such as and, or, a, the so the total text surrounding your focus or search word will be about 1.7x the number of words defined by the .VK command.

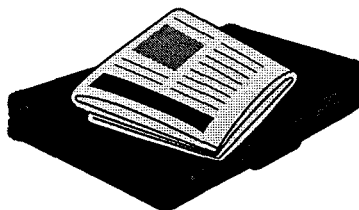

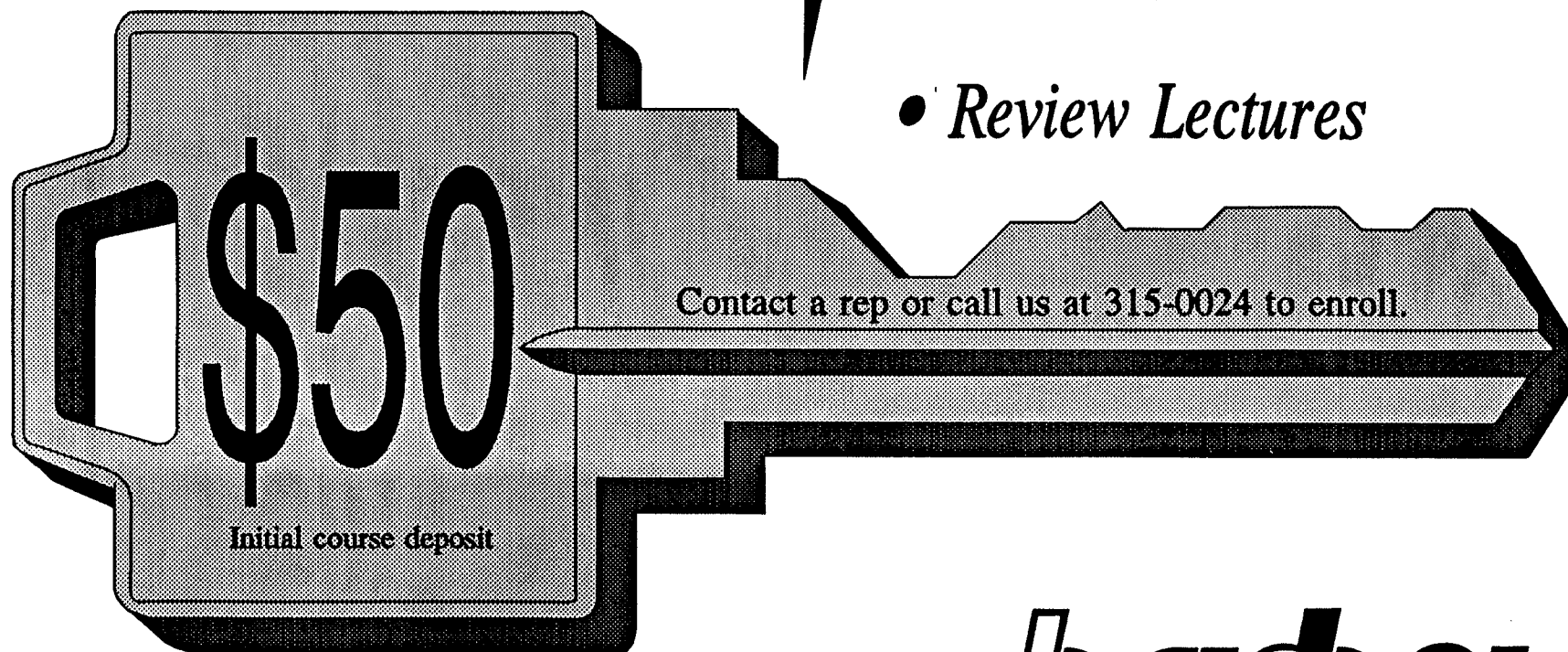
