SBA News

Rumors have been heard that the recent revised examination schedule was the result of the Student Bar Association lobbying the Administration on behalf of a few students who had poor examination schedules based on the original schedule. Because a rumor such as this impugns the SBA, we feel obligated to dispel this rumor.

The SBA began working on behalf of all students to change the examination policy in July, 1991. We requested that examination schedules be published concurrently with the class schedule. In the alternative, we requested that the examination conflict policy at least be changed to define exams within 24 hours of each other as a conflict.

The faculty granted our alternative request in October. To assist in implementing the positive changes as soon as practicable, Dean Morgan asked all of those concerned to attempt to rewrite the Fall, 1991 examination schedule reflecting the new examination conflict policy. The new schedule reflects this policy.

As with any policy, some people fare worse than others. Overall, this conflict policy is in the best interests of all students. The SBA did not petition Dean Morgan on behalf of any student. Rest assured that the SBA will continue to press for the publication of examination schedules concurrently with the class schedules.

If you have particular concerns that we can address, please let us know.

Highlights of the 11/14 SBA Meeting

Library Committee: Student suggestions will be addressed by the faculty committee in 1992.

Budgets: Allen Turnage requested that the SBA budget be published in *The Docket*, along with a description of how the budgetary process works.

Commencement Speaker: Proposed speakers include Lamar Alexander, Morris Dees, Jimmy Carter, Billy Payne, and Griffin Bell. The SBA took an informal vote and recommends that Morris Dees be asked to speak.

Constitutional/By-Law Amendments: SBA members have been asked to review the proposed amendments and give comments back to the drafting committee in preparation for taking the amendments before the Student Body at the next election.

Bookstore: The SBA Bookstore has done well and will continue next semester. The Docket gives the dates for accepting books for sale next semester. Concern was expressed regarding what to do with abandoned books. The consensus was disposal/recycling.

Law School's 10th Anniversary: Dean St. Germaine has received a letter from Dean Girth asking her to establish an advisory group which will act over the next two months to suggest events for the Law School's 10th Anniversary. From this core group, a full advisory committee will be appointed to carry the suggestions into action. Volunteers are to be solicited from among SBA representatives and members of other Student Organizations. Pam Sullivan volunteered to represent the SBA on the Committee.

January 1992 Hooding Ceremony: Plans are proceeding for the January 1992 Hooding Ceremony, according to Dean St. Germain.

Spring Class Schedule: The Spring schedule apparently leaves only 1 elective that does not conflict with required 1st and 2nd year classes. Dean Morgan is aware of the problem.

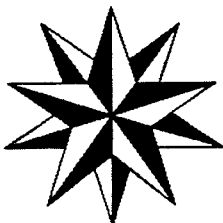
VITA Committee Report: Kristen Van der Linde reported that she has been unable to contact the VITA National representative, but will continue her efforts.

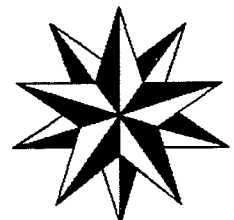

The False Environmentalism of Paper Cups

It has come to my attention that there have been complaints about the use of styrofoam cups by the SBA in its coffee service as well as by Sands (in whatever the new name of the cafeteria is). This concern seems to be based on the notion that styrofoam is the product of the devil (or at least some equivalent entity such as DuPont) and that paper cups are infinitely preferable to this non-biodegradable, non-recyclable scourge of the planet which is causing our ozone to be depleted and our landfills to overflow.

Neither of these concerns has much merit. although most styrofoam is indeed produced with CFCs as a step in the process, styrofoam cups that do not use CFCs are widely available and are becoming more prominent. If the SBA is not using such cups, perhaps it would be wise for them to switch. Besides, CFC pollution from styrofoam manufacture is infinitesimal compared to the major source of CFC contamination, which is air conditioning and refrigeration units and until very recently (at least in most of the rest of the world)

aerosol cans.

Paper production, on the other hand, is an extremely polluting process both for the air and the water, as anyone who has been to Savannah, Rome or Jacksonville knows. Paper mills in Georgia are by far the biggest single industrial polluters in the state. Paper production takes up to twenty times as much water as styrofoam production and results in the creation of chemicals such as dioxins, which may or may not be some of the most toxic chemicals known to man.

As for the landfilling of styrofoam, it is simply not true that styrofoam is not recyclable or that it is worse than paper in a landfill. The confusion seems to arise in the difference between whether something is recycled rather than recyclable. Unfortunately, neither paper nor styrofoam cups are recycled extensively. Therefore, both usually end up in a landfill where a paper cup will take up just as much room as a styrofoam one.

It can even be argued that styrofoam is preferable in landfills because it is so inert. As paper breaks down in a landfill (and it does so very slowly) methane gas is released, one of the greatest pollution concerns from a sanitary landfill. Styrofoam will simply remain in the ground as it was placed there, neither degrading nor producing noxious or flammable gasses.

Paper cups, in particular, present a problem for recycling for two reasons: first, paper cups are treated with wax and other chemicals to make them waterproof and heat resistant making the recycling of paper cups complicated and expensive; and second, because there is such a glut of paper for recycling (the supply far outweighs the demand) industry has no incentive to make the special arrangements necessary to recycle paper cups. On the other hand, styrofoam can simply be thrown in with other plastics to make such useful items as picnic benches and insulation.

So, before the knee-jerk reaction that paper is good and plastic is bad, think about the entire process and decide which is the greater evil.

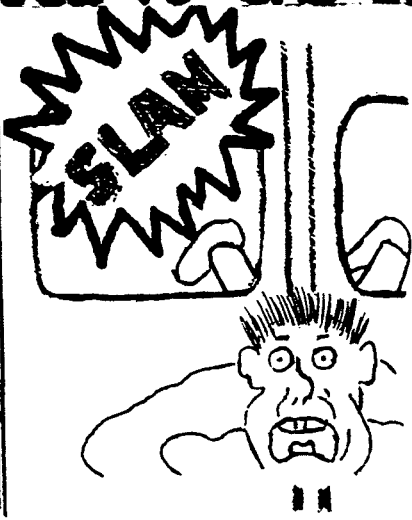
