## LETTER FROM THE DEAN

The level of activity at the College is certainly enlivened by your return from the holidays, and I welcomed the tangible change of pace yesterday. I hope that the end-of-year break was refreshing for you and that you are looking forward to this semester's activities as much as I am. As I indicated in December, this month we welcome back Prof. Ray Lanier from his year-long research leave in Austria and wish Prof. Charles Marvin well as he leaves for Kazakhstan and Bulgaria on public service and teaching assignments.

For this semester, we are also welcoming to our faculty a full-time visitor, Professor David Hendrick, who has most recently been a visiting professor at Southern Illinois University. Prof. Hendrick will be teaching in his areas of expertise, Property II and Real Estate Finance, and we are very pleased that he is able to spend this semester with us.

I also appreciate the substantial efforts that representatives of the Student Bar Association devoted to interviewing faculty candidates during December. The candidates have all told me how much they enjoyed their visits with your representatives, and we are proud to give them that opportunity. The University's budget constraints limit our hiring for tenure-track positions to appointments at "junior" levels, and we will be hosting another series of candidates for such positions during the first two weeks of this semester. Our goals as we seek additional faculty members include sectioning of additional first-year courses in the day program and increased availability of electives for both the day and the evening programs.

This season of the year also gives us the opportunity to congratulate our January graduates and to wish them well as they pursue their professional careers. This year's planning committee, coordinated by Mike Berlon, has decided to celebrate with a hooding ceremony which is comparable to the one which we host for our June graduates. It should be a very upbeat occasion.

As many of you know, I decided that the College could no longer afford to continue Dean Knowles' very recent practice of financing a separate University Commencement in January from the College's budget. Staging a formal Commencement on behalf of the University requires a staffing commitment and cash outlays from the College's budget of very substantial proportions. Most of this activity occurs "behind-the-scenes", but the costs are nonetheless real, and they absorb funding that could otherwise be used, as examples, for student services and financial aid. By comparison, the College's customary "hooding" occasion is much less expensive and can be managed within our budgetary limits. This year the College must absorb the deferred effects of the very substantial budget cuts that were imposed upon us last year, and I anticipate that our public funding will continue to be limited for the foreseeable future.

Within these constraints, we are all working hard to continue our tradition of excellence in legal education. Next month we will again co-sponsor the Annual Southern Banking Law Conference with the Federal Reserve Board. In addition, the BLSA Regional Conference will be hosted in Atlanta, with significant participation by members of our BLSA organization. I am looking forward to participating in both events and urge you once again to take advantage of this kind of educational opportunity which occurs outside the formal classroom.

He was an editor of Amethyst, a writer for Southern Voice and The News, and founding editor of The Journal of AID Atlanta.

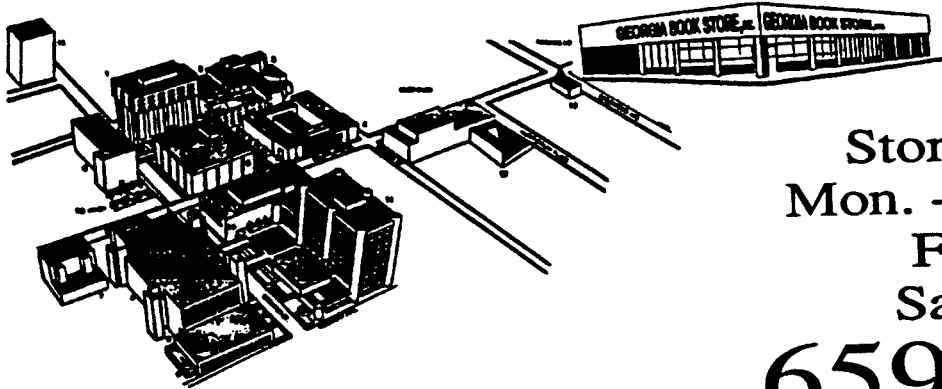
