Law Library Renovation—2003

Popular wisdom has it that technology will come to the rescue and do away with the need to continue adding space for library book storage. Actually, it will be some years before a substantial percentage of the information libraries seek to collect will be delivered electronically.

The size of the hard-copy collection remains constant. A scenario more plausible than that of a paperless, virtual library is one in which a library has a combination of hard-copy and electronic resources. The Law Library will continue to need shelving to house the physical collection,

work stations for computing, and quiet areas for studying.

To plan for additional shelving, the Law Library recently added 7,500 gross sq. ft. with the completed renovation of the first floor of the University Center. This space provides wired seating for 50 library

users and shelving for 20,000 books. With the new space, the library should gain about 8-10 years of growth. Additionally, the new area houses an expanded microforms room and a copy/printing room. As an added bonus, students

Dean's Message

Our twentieth anniversary year concluded with Congresswoman Denise Majette's inspirational hooding ceremony address on May 9, 2003. One of the first African-Americans to attend Yale University, Denise Majette has proved over and over again that adversity is something to overcome and obstacles are merely challenges to meet. After serving as a State Court judge in DeKalb County for almost ten years, she decided to run for Congress in 2002. Fighting against the odds by taking on a powerful incumbent, she won the primary and went on to win the general election with 77 percent of the vote.

Congresswoman Majette's career of exemplary public service brings to mind the legal profession's responsibility to advance the public good. What did we do at the law school during our twentieth anniversary year to stress the importance of public service?

Our Curriculum Committee, as part of an on-going study, proposed the creation of a program to increase pro bono participation. A new policy, adopted by the faculty in March 2003, provides that students who complete 50 hours or more of pro bono service shall graduate with "pro bono distinction." These students will be recognized by a notation in the graduation program and the receipt of a certificate.

Under the leadership of Student Bar Association President Erin Baird,



our students engaged in many pro bono activities last year. They earned recognition as the second largest fund raising team in the annual Breast Cancer Walk by raising over \$7,500. Children at Hughes Spalding Hospital enjoyed the Halloween treat bags our students delivered to them. During Law Week, students collected donations for "My House," a non-profit organization that cares for medically fragile abandoned babies. Other activities included reading books to students at Wadsworth Elementary School and participation in a mock trial presentation to elementary students.

Our tradition of outreach to the state and legal profession continued with the annual publication of the *Law Review's* Peach Sheets. Students enrolled in the Legislation Clinic aided state legislators by writing legal commentaries on various initiatives, including proposals for higher ethical standards in the operation of state government, the repeal of the premarital blood test, and authorization for counties to collect franchise fees.

The law school also continued its tradition of state and local problem-solving assistance. Professor Mark Kadish served as a member of a blue ribbon panel that studied the operations of the Atlanta Municipal Court and the Atlanta Traffic Court. The panel's well-documented study provided a blue print for major reforms in Atlanta's municipal court system that are now being implemented.

These numerous volunteer and service activities demonstrate our commitment to serve the community and our belief that public service is a vital aspect of the legal profession.

On April 15, 2003, the College of Law honored Bob Shuford as he stepped down from his leadership position as the law school's Associate Dean for Administration. Bob has already made a transition to his new teaching career at Georgia Perimeter College.

At the reception in his honor, Dean Janice Griffith thanked Dean Shuford for his 32 years of dedicated service to the University and praised his many accomplishments. She spoke of Bob's great talents as a problem solver. "He is a financial and human resources wizard who knows how to get the job done quickly and efficiently," she said. "He has had a hand in all of the college's great accomplishments during his 16-year tenure here." For example, Griffith pointed out that the college went through the technological revolution over the last decade with hardly a hiccup and emerged as the 11th most wired law school in the country. FACULTY BRIEFS

Mark Budnitz published an article, "Consumer Payment Systems: New Products and Services, New Laws and New Problems," in *Consumer Finance Law Quarterly Report*. He also published a new supplement to his book, *The Law of Lender Liability*. He presented a paper, "The High Cost of Consumer Arbitration: Green Tree and Its Aftermath" at a symposium, *The Coming Crisis in Mandatory Arbitration: New Perspectives and Possibilities*, sponsored by Duke Law School. He submitted an article on the cost of consumer arbitration to *Law and Contemporary Problems*. Budnitz also presented "No Access to Lawyers or Courts: A Significant Cause of Poverty" at the Atlanta Conference on Poverty. He co-chaired meetings of the Working Group on Consumer Protection of the American Bar Association's Cyberspace Law Committee.

As Co-Chair of the ABA International Law and Practice Section Central and Eastern Europe Committee, he moderated a panel and spoke on Recent Legislative Changes in the Baltic States and Russia at the Section's Spring Meeting in Washington, D.C.

Ellen S. Podgor recently published two articles: "Defensive Territoriality: A New Paradigm for the Prosecution of Extraterritorial Business Crimes," 31 *GA. J. Int. & Comp. L.* 1 (2003) and Extraterritorial Criminal Jurisdiction: Replacing "Objective Territoriality With Defensive Territoriality," 28 *Stud. L., Pol., & Soc'y* 117 (2003). She also authored an article titled "The 'USA Patriot Act' and Computer Crimes," that appeared in a Symposium issue on "Justice in the Balance: The Aftermath of 9/11" in 17 *Crim. Justice* 61 (2002). In addition to her continuing service on the Board of Directors of the National Association of Criminal Defense Lawyers (NACDL), she is serving on the Members Consultative Group of the American Law Institute's Model Penal Code: Sentencing Project, on the Board of Directors of the International

Society for the Reform of Criminal Law and on the Executive Board of the International Association of Penal Law-American National Section.

Mary Radford has been appointed Reporter of the Trust Code Revision Committee of the Fiduciary Law Section of the State Bar of Georgia. She is also the Reporter for the Guardianship Code Revision Committee, which presented a comprehensive revision of Title 29 of the Georgia Code to the state legislature in January, 2003. Professor Radford is co-chair of the Legal Education Committee of the American College of Trust and Estate Counsel (ACTEC), program chair for the SE Regional ACTEC meeting to be held in Savannah in October, chair-elect of the Association of American Law Schools (AALS) Section on Donative Transfers, Fiduciaries, and Estate Planning and program chair for that section's program for the AALS annual meeting in Atlanta in January 2004. Professor Radford has given the following presentations: "Construction and Interpretation of Wills;" "Use of Disclaimers;" "Recent Developments in Georgia Fiduciary Law;" and "The Changing American Family and Its Effect on Probate Law." She also completed a 2002 supplement to her treatise, *Redfean's Wills and Administration in Georgia*.

Charity Scott published an article entitled "Should Professors Profess in the Classroom?" in the *Law and Bioethics Report*, and also organized and moderated a plenary panel session on the same topic for the annual Health Law Teachers Conference sponsored by the American Society of Law, Medicine and

Ethics in June 2003 in Wilmington, Delaware. As Chair of the ABA Health Law Section's Interest Group on Medical Research, Biotechnology, and Clinical Ethics, she organized and moderated a program entitled "Human Research Subjects: Assessing the Adequacy of Protections and the Need for Reform," at the Section's 4th Annual Mid-Year Conference on Emerging Issues in Healthcare Law in February 2003 in Miami. Professor Scott was invited to participate in a two-day workshop at Northeastern University in April 2003, to examine ways to improve nationally legal education in public health law. On a related note for the spring semester, she helped to facilitate a new course offering at the College of Law on public health law, taught by distinguished faculty from the Centers for Disease Control and Prevention (CDC). In June 2003, she was appointed to Chair a university-wide Blue Ribbon Committee on Human Subjects Protections at Georgia State. Professor Scott was honored by the Student Bar Association's "Outstanding Professor of the Year" award in April 2003 at the College of Law.

Jack Williams spoke on excessive compensation before the Annual Meeting of the Society of Business Editors and Writers in Boston. He also spoke on consumer bankruptcy law, bankruptcy taxation, and the role of financial advisors in bankruptcy at the Annual Meeting of the American Bankruptcy Institute in Washington, D.C. Professor Williams was an invited speaker on business ethics and recent developments in bankruptcy at the annual meeting of the Association of Commercial and Finance Attorneys in Kiawah, South Carolina. During the summer, he briefed the Department of Homeland Security, the Defense Intelligence Agency, and the

Central Intelligence Agency on his research in strategic threat assessment and Islamist terrorism.

Douglas Yarn was an invited speaker at the 2nd Annual Conference on Neuroesthetics at UCLA-Berkley where his topic was Neurobiology and the Aesthetics of Justice. He participated in a symposium at Penn State law school on Dispute Resolution and Capitulation to Routine: Is there a Way Out. His symposium paper, The Death of ADR: A Cautionary Tale of Isomorphism Through Institutionalization, will be published in the next *Penn State Law Review*. Another article, Evaluative Dispute Resolution under Uncertainty: An Empirical Look at Bayes' Theorem and the Expected Value of Perfect Information, co-authored with CNCR Research Fellow and GSU graduate Gregory Jones, will appear in the upcoming issue of the *University of Missouri-Columbia's Journal of Dispute Resolution*. Professor Yarn's traditional Irish music and ceili band, Banish Misfortune, won the Athens' Battle of the Bands in May.

Patrick Wiseman's course on Law and the Internet, and the technology he developed to deliver it, is a featured case study in the new book, *Distance Education: The Complete Guide to Design, Delivery, and Improvement*, by Judith L. Johnson, Director of the Office of Institutional Research at the University of Southern Maine, a nationally recognized expert in distance education.
