
Obviously, these kinds of opportunities have the potential to expand our horizons and refining our perspectives. I hope that they will also be fun for you.



## THE HONORABLE SANDRA DAY O'CONNOR

Justice O'Connor was born in 1930 in El Paso, Texas. She went to school in El Paso and spent her summers on her grandfather's ranch in Arizona.

After graduating from high school, Justice O'Connor attended Stanford University where she earned a degree in economics, and a law degree. She was editor of the *Stanford Law Review* and a member of the Order of the Coif, a legal honor society. At law school, she met John J. O'Connor, III, whom she married in December 1952.


Justice O'Connor accepted a position as deputy attorney for San Mateo County, California. She later moved to Germany with her husband where she worked as a civilian attorney for the U.S. Army. In 1957, the O'Connors settled in Phoenix, Arizona where they raised a family.

In 1965, Justice O'Connor became an assistant attorney general of Arizona, the first woman to hold the position. Four years later, she was appointed to the state Senate, and the following year she won election to that body.

In 1974, Justice O'Connor was elected as Superior Court Judge of Maricopa County. Five years later, she was appointed to the Arizona Court of Appeals. It was from this position that President Ronald Reagan nominated her to the Supreme Court.

**GSU STUDENTS HELP ATLANTA'S  
POOR FACE THE IRS**

GSU Law Professor Ronald W. Blasi is the director of the newly formed tax clinic at the College of Law. The tax clinic, located on the ground floor opposite the Career Planning Office, offers free advice for Atlanta's indigent taxpayers. The staff is comprised of GSU law students who have completed basic tax courses and received clinic training from IRS officials.

A licensed attorney will supervise the students as they represent their indigent clients before the IRS and the U.S. Tax Court. The College received clearance from the U.S. Tax Court and the U.S. Treasury Department for the program, the first of its kind in Georgia.

The advisory clinic for the committee is made up of many of Atlanta's most respected tax attorneys. Firms represented on the board include King & Spalding; Powell, Goldstein, Frazer & Murphy; Troutman Sanders; Morris, Manning & Martin; and Frantz, Sanders & Grattan.

The clinic has received a \$90,000 grant from The Trammell Foundation, a legal-aid foundation administered by Alston & Bird. This amount will fund the clinic for three years. An additional \$50,000 has been earmarked by the foundation provided the College raises \$150,000 by 1996.

**STLA SELECTS COMPETITION TEAM**

On Thursday, September 10th, special try-outs were held for positions in the Tournament trial competition team. This competition will take place in Houston, Texas, on October 14-17. The top 16 trial teams in the country will be competing.


