## Major Accomplishments

With a shared vision of the College of Law's future as a premier urban law school in the country, the faculty, staff, and administrative leadership of the college made great strides during the 2000-2001 year in advancing faculty research and scholarly activities, community outreach and public service, interdisciplinary and international relationships, development and fund raising efforts, and the integration of technology into all aspects of the college's academic endeavors. Below are major highlights of a busy and successful year.

### Scholarship

The impressive record of scholarly research and publications by the faculty of the College of Law continues, building an ever greater professional reputation for themselves and contributing to an increasing scholarly reputation for the college and university. Legal scholarship constitutes an important part of the college's mission to provide new insights on molding the law to better serve our society. Many of the faculty engage in original and influential scholarly inquiry. The appendix indicates the productivity of the faculty in their scholarly endeavors and reflects an increase in scholarship in tune with the college's articulated goals and promotion and tenure policy. Only a portion of faculty endeavors can be mentioned in this summary.

### Technology

The integration of technology into all aspects of the college's academic endeavors continues at a fast pace. The resulting reputation of Georgia State University College of Law as a leader in technological innovations was recognized again by the National *Jurist* Magazine, which ranked Georgia State as the 11<sup>th</sup> "most wired" law school in the country, a move up from our 20<sup>th</sup> ranking in 1998.

The College of Law web pages continue to be a valuable instrument in communication with the public and for the internal benefit of the faculty, staff, and students. Inquiries of incoming first year students showed over ninety percent reviewed the college's web pages during their deliberations as to which law school to attend. More students each year utilize the online

application process. Once admitted the students access the web for the college's bulletin, curriculum planning guide, information about the faculty, course descriptions, syllabi, class assignments, and notices of upcoming law school events. Later in their program at Georgia State they will take advantage of the on-line placement bulletin. If students participate in the Tax Clinic, they will access necessary documents and information from the college's on-line content. The electronic reserve system has been a big success for the Law Library. Course materials placed on reserve by faculty for students in their courses are available online for students to download electronically.

An important achievement this year was the redesign of the college's web site using the "portal" concept to cater to various constituencies. Part of this redesign was the installation of a new web server to house the new web site and support its search engines, active server pages, and web-based databases. This past year also saw the creation of a web-based final exam-scheduler to minimize exam-scheduling conflicts. The on-site training program for faculty and staff on the standard software used by the college was greatly expanded and was extended to students for the first time.

Another major project this past year was the development of an interactive CD-ROM to be included in the admissions Viewbook that will be distributed to perspective students beginning in the fall of 2001. Based on data that is shared by the new web site, the CD-ROM provides information as well as web links to various sites at the college and the university that applicants will find valuable in making their selection decision.

The college has been fortunate to enhance its hardware resources with funds from the student technology fee and from the salaries of professors visiting other institutions. New personal computers were purchased for all faculty as a first step in upgrading all PCs used by faculty, staff, and students in the college. Furthermore, new machines were purchased for the open student lab and the training lab; special machines were purchased for public e-mail stations in the lobby of the Urban Life Building; additional wired carrels were purchased for the Law Library; and a number of laptop machines were procured for checkout in the library.

At the commencement of the fall 2000 semester, Lecture Hall 100 was returned to the classroom inventory after a complete renovation. New tables and seating provide electricity and network data ports at each student work station. In the spring of 2001 at the conclusion of final exams, contractors began the demolition of Classroom 230 in preparation of a similar renovation. This is the third of a four-part project to provide data line access to all student work stations in the four large-tiered classrooms that are the core of the college's instructional facilities.

Professor Patrick Wiseman, a leader among the faculty on instructional technology, received the first Tom Creed Memorial Compassionate Pioneer Award from the TLT Group (Teaching, Learning, and Technology), an Affiliate of the American Association of Higher Education. Professor Wiseman was cited for his use of technology to enhance his courses and increase communication among faculty and students, and for sharing his expertise well beyond his own academic unit.

The college continues its contractual relationship with the Georgia Courts Automation Commission for the development of a pilot project on the electronic filing of court documents. A graduate of the law school continues to serve as principal staff for this exciting project, which will ultimately alter forever the processing of documents in the legal system in Georgia.

### Development

The development effort of the college had several notable accomplishments during 2000-2001. There was substantial growth in the annual fund from \$34,000 to nearly \$67,000 as of July 3, 2001. This past year the college received its largest pledge from a graduate to date of \$50,000 for a challenge grant to match the annual fund. A similar challenge will be offered again next year. Furthermore, there was an increase in the number of leadership donors (\$1,000 and greater). Besides these immediate successes, the groundwork was laid for further successes in the future by the many contacts made, proposals submitted, and potential donors identified.

The College of Law has been fortunate to receive funding for support of its Tax Clinic over the years. This past year saw the establishment of a Tax Clinic endowment funded from previously collected donations. The endowment will ensure the continued operation of this valuable function that benefits our students and the general public.

### International Relationships

The college was quite proud of Professor Charles Marvin, who received a Fulbright Fellowship to live and teach in Latvia for the past academic year. This valuable experience follows previous international relationships of Professor Marvin with university and government officials in Bulgaria, Croatia, and Kazakhstan. For a third year in a row, Professor E. R. Lanier was selected to participate in the University System of Georgia's international faculty development seminar. This year he visited Havana, Cuba. Julian Juersgensmeyer was appointed to the Panel of Arbitrators of the International Court of Arbitration, Warsaw, Poland.

The principal on-going international relationship of the college is the foreign summer program headed by Professor E. R. Lanier, which takes upward of 50 students to Europe to study international commercial arbitration. This past summer saw the expansion of the program to Warsaw, Poland. The program now visits the arbitration courts in the major cities of Central and Eastern Europe.

A number of German students were in residence at the College of Law this past year, coming for a semester to conduct legal research and complete an academic paper dealing with tax and financial institutions. This long-standing program is directed by Professor Ronald Blasi.

### Interdisciplinary Activities

The College of Law engages in interdisciplinary and interdepartmental cooperation. Law

faculty teach courses in the Colleges of Arts and Sciences, Business Administration, and Education. Correspondingly, a member of the Risk Management and Insurance faculty of the College of Business teaches insurance law to College of Law students. William Edmundson accepted a joint appointment with the Department of Philosophy and continued to serve on the Advisory Board of the Arts and Sciences based Jean Beer Blumenfeld Center for Ethics. In addition, Charity Scott has established an interdisciplinary program and seminar with Emory University Medical School in the area of bio-medical ethics.

The College of Law now has three joint programs with other colleges at Georgia State University. This year a new joint degree program for a J.D./M.A. in Philosophy with the College of Arts and Sciences was approved. The college is engaged currently in conversations with the College of Architecture at Georgia Institute of Technology for a joint degree program in law and city planning.

#### Center on State Law, Legislation and Policy

During the past year the College of Law engaged in extensive outreach and planning that has resulted in the inaugural semester of a Legislation Clinic in the Fall 2001 semester. This Clinic will create various linkages between the College of law and the Georgia legislature. During the upcoming year each student in the Clinic will be assigned to a legislative committee. Working with the chair of the committee, the student will conduct a significant legal analysis of one of the issues that the committee plans to address during the upcoming legislative session. Once the session begins and the research project has been completed, the student will be placed with the committee to **perform** continuing analysis on that issue and other pending legislation. The planning efforts of this past year included extensive meetings with leaders of the Georgia General Assembly, its various research offices, and various public and private organizations that provide research and information to the state legislature. In addition, members of the College of Law faculty met with faculty from other law schools who run similar programs, at both public and private universities.

#### Community Outreach and Public Service

The Consortium on Negotiation and Conflict Resolution (CNCR) conducts research into the nature of conflict and the theories and principles of resolution while applying this knowledge in training and educating others in mediation and resolution. The consortium is an interdisciplinary and inter-university partnership that supports the Board of Regents' Initiative and Policy Direction on Conflict Resolution. CNCR has just completed the second year of its program of conflict resolution in the Atlanta Public Schools where students from Georgia State and other local universities are trained to teach conflict resolution to students, administrators, teachers, and parents. CNCR expects this program to be an immense benefit to the climate of the public schools involved. Besides support from the College of Law, the consortium has been the recipient of funding directly from the Board of Regents and from several outside funding agencies. During this last year the consortium held grants from the U.S. Department of Education's Fund for the Improvement of Post Secondary Education (FIPSE) and the Hewlett

Foundation.

The Tax Clinic continues to receive support from the Internal Revenue Service to fund the clinic's activities. The Georgia State University Tax Clinic serves low-income individuals who are involved with disputes with the Internal Revenue Service. Besides this public service, it is an important laboratory for the training of law students and graduate tax students from the College of Business Administration. More than 500 cases have been handled by students since the inception of the clinic, and it remains the only such entity in the southeast. Despite the adversarial role of the Georgia State Tax Clinic, the IRS respects the clinic for its success in providing equitable solutions for troubled taxpayers.

In cooperation with the Georgia Courts Automation Commission, the College of Law sponsors the Electronic Court Filing Project, a project to explore the automation of Georgia's courts through the electronic filing and signing of court documents. The project's research encompasses and impacts on the areas of digital signatures, electronic records and signature legislation, and national legal and technical standards development, including Legal XML.

Three law school faculty served as reporters to Georgia Code revision committees, charged with updating state laws. Contributing their time, effort, and scholarly expertise, Associate Dean Steven Karninshine worked on labor law revisions, Professor Ellen Taylor assisted in rewriting sections dealing with investment advisors, and Professor Mary Radford participated in revisions of guardianship law.

At times faculty members serve as *amici curiae*, experts invited to advise a court on a matter of law in a case to which they are not a party. This past year Professor Natsu Saito wrote and filed an amicus brief on international law questions in *Henry Koshio v. United States*, United States Court of Appeals for the Ninth Circuit.

As part of the college's efforts in strengthening and increasing community outreach and public service, law faculty serve in leadership positions and on numerous committees for the Association of American Law Schools, the American Bar Association, the State Bar of Georgia, and for other local and regional organizations where their legal training is of value. Ronald Blasi served on the Editorial Advisory Board of the Journal of Financial Institutions Taxation. James Bross chaired the AALS Section on Agricultural Law. Mark Budnitz was a member of the Uniform Commercial Code Committee of the American Bar Association and served on the Board of Directors of the Atlanta Legal Aid Society. William Edrundson was a member of the Committee on Philosophy and Law of the American Philosophical Association. Anne Emanuel served as Board Secretary, Georgia Center for Law in the Public Interest. Marjorie Girth continued as Board Member of the American Civil Liberties Union of Georgia and member of the Georgia Supreme Court Commission on Equality. Dean Janice Griffith served as a member of the Executive Committee of the AALS Section on State and Local Government Law. Dean Griffith also served as a member of the American Bar Association's New Deans Seminar Planning Committee. Bernadette Hartfield continued to serve on the Board of Trustees of the Law School Admissions Council. Nancy Johnson, Law Librarian and Professor of Law, served



on the American Library Association Task Force on Accreditation and the Editorial Board of Legal Reference Services Quarterly. Julian Juersgensmeyer was appointed to the Panel of Arbitrators of the International Court of Arbitration, Warsaw, Poland. Steven Kaminshine was named the incoming Chair and Executive Board Member of the Labor and Employment Law Section of the Atlanta Bar Association. Marjorie Knowles was a Board Member of the International Institute for Corporate Governance and Accountability and continued her long time service as a Trustee of TIAA/CREF. E. R. Lanier was a member of the Board of Trustees of the Institute for Continuing Legal Education in Georgia. He also served as a member of the Editorial Board of the Croatian Arbitration Yearbook. Charles Marvin served as Chair-Elect of the AALS Section on Law and Africa Paul Milich was Secretary/Treasurer of the Bleckley Inn of Court. Ellen Podgor co-chaired the Discovery Reform Committee of the National Association of Criminal Defense Lawyers. Mary Radford continued her long service on the Executive Committee of the Georgia Appellate Practice Resource Center. Natsu Saito sat on the Board of Directors of the Society of American Law Teachers. Charity Scott was Vice Chair, Clinical Ethics Interest Group, Health Law Section, American Bar Association. She also served as Vice Chair, Clinical Ethics Interest Group, Health Law Section, American Bar Association. Eric Segall was on the Executive Committee of the AALS Section on Federal Courts. Roy Sobelson continues to serve on the Georgia Chief Justice's Commission on Professionalism. Jack Williams served on the Board of Advisors, Bankruptcy Law Journal. Douglas Yarn is a consultant to the Permanent Court of Arbitration, The Hague.

### Law Library

The Law Library is an indispensable component of the college, and considerable effort and funding is expended each year to maintain the law library. Although no new funding for acquisitions was received this past budget cycle, the library has benefited greatly from the student technology fee. The new computers for the open lab, wired carrels to allow use of laptops throughout the facility, a new microform scanner, and other purchases will help the library meet the ever increasing demand for technical services from students.

The Library awaits the completion of the University Center renovation project, whereby it will receive approximately 6,000 square feet of space for bookshelves and student seating. The microforms will be relocated to this new space, permitting an expansion of the student computer lab.

### Admissions and Student Recruitment

The College of Law and its Office of Admissions undertook several new initiatives this year in an ongoing effort to attract an outstanding and diverse student body. These efforts primarily focused on activities designed to increase outreach to applicants who already had been admitted but had not yet decided to attend the College of Law. As part of this outreach, the College of Law created a new program, "A Day in the Life of the Law School," in which admits were invited to visit the College of Law, tour the facility, attend classes, and meet with the dean and student leaders. New outreach efforts also included inviting selected admits to special

College of Law events such as the Henry Miller Lecture, the Law Review Symposium, and Law Week. Several College of Law faculty members also assisted in outreach by contacting many admits by telephone.

During this year the Office of Admissions also coordinated an upgrade of our primary recruitment publications, which include the Viewbook, and several brochures that highlight particular programs and opportunities. The new Viewbook is not only a high quality print publication, it also now includes an attached interactive CD Rom that allows applicants quick access to important information and the ability to link to the College of Law's web page.

### Student Achievements

The College of Law continued its success in student moot court and mock trial competitions. Numerous teams competed in intrastate, regional, and national competitions. Notable activities this past year included impressive performances in the National Trial Advocacy Competition and the William Daniel National Mock Trial Competition. The Georgia State team placed 5<sup>th</sup> out of 24 at the National Trial Advocacy Competition, in which one Georgia State student received a Best Advocate award. At the William Daniel National Mock Trial Competition, Georgia State University was a national semi-finalist, finishing 3<sup>rd</sup> out of 26 teams. Two teams advanced to the national competition. The Frederick Douglass team was one of three southeastern teams to advance to the national competition.

Both as an outstanding student achievement as well as an important resource to the community, Georgia State Law Review students sponsored a symposium on urban sprawl that attracted journalists, academicians, and members of the bench and bar. Speakers included Joel Cowan, chairman at the time of the Georgia Regional Transportation Authority; President Carl Patton; and faculty members from metropolitan Atlanta universities, the University of British Columbia, and the University of Warsaw. The papers presented at the symposium are being prepared for publication by the Law Review.

Students made many contributions to the community over the last year, participating in feeding the hungry and homeless, cleaning up local rivers and streams, and performing many other community service projects. Under the sponsorship of the Student Bar Association, an entire week of projects, seminars, and speakers was organized by various student groups in celebration of Law Week.

### Major Faculty or Staff Changes

The end of the 2000-2001 academic year saw the departure of two teachers, Shubha Ghosh of the regular faculty and Wendy Hensel of the reading, writing, and advocacy faculty. The college is recruiting presently for a replacement for the former, and Lisa Bliss has been hired to fill the latter vacancy. During the past year, the library lost Rhea Ballard-Thrower and Suzanne Mucklow from its professional staff. Kris Niedringhaus has been hired as the new associate librarian, and Beth Adelman has been hired as a new reference librarian.

## Progress in assessing Institutional Effectiveness

The College of Law has long identified several instruments or measures to assess institutional effectiveness. Success of student teams in moot court and mock trial competitions reflects the rigorous intellectual preparation and practical lawyer skills that students receive in class. The College of Law has a long record of student achievement, and the past year proved no different. College of Law students fielded 18 teams in 15 competitions around the country this past fiscal year.

A valuable tool for measuring institutional effectiveness for the College of Law is the success rate of students sitting for the Georgia Bar examinations. Successful passage of such examinations is a requirement for entry into the legal profession. From its inception, the College of Law at Georgia State has built an impressive record of success on bar examinations. The principal date for taking the exam is in July after the spring commencement. Another testing is done in February for the few who graduate in December or who are repeating the test. For the July 2000 administration of the Georgia Bar Exam participants trained at Georgia State University had a 91.1% over-all pass rate. Those College of Law students taking the test for the first time had a passage rate of 93.4%. For the February 2001 administration of the test all takers affiliated with Georgia State had a rate of 78.7% and first time takers had a rate of 85.2%.

Employment statistics six months after graduation are a standard measure used for assessing legal education and are annually collected by the College's accrediting agency, the American Bar Association, and by U.S. News and World Report for its edition on rating graduate and professional schools in America. The figures for the class of 2000 show an employment rate of 95.43%. Employment in large (51 to 100 lawyers) and very large (over 100) firms is prized and highly competitive. The percentage of Georgia State graduates employed in this category represents 17.36% of the 2000 class. This means that our chosen graduates were picked from regional and national pools of graduates representing some of the most prestigious law schools in the country.

Another measure of the effectiveness of legal instruction received as a student at Georgia State's College of Law is the success of graduates in achieving partner in prestigious law firms, appointment of election to the bench, and service as legal counsel for major corporations. Georgia State graduates are now partners in Alston & Bird; Arnall, Golden & Gregory; Holland & Knight; Jones, Day, Reavis & Pogue; Kilpatrick & Stockton; King & Spalding; Powell, Goldstein, Frazier & Murphy; Long, Aldridge & Norman; and others. A number of Georgia State College of Law graduates serve as assistant district attorneys and magistrate judges, and several hold State Court and Superior Court judgeships. Numerous corporate legal offices employ College of Law graduates including AT&T, BellSouth, Cox Enterprises, Equifax, Federal Reserve Bank, Georgia Power, and Georgia-Pacific.

## **Retention & Graduation**

The summer skills program and the academic enrichment program are two valuable activities at Georgia State University College of Law to assist with student retention and graduation. Both of these entities are intended to improve the success rate of students who are deemed to be at risk of experiencing academic difficulty in law school. The summer skills program is a pre-start program that takes place prior to the beginning of the academic year for first year students. The academic enrichment program takes place during the regular school year and consists of tutorials offered by upper level students under the direction of a faculty committee.
